The filled in application Forms should positively reach the office of the undersigned on or before **31<sup>st</sup> October, 2015**. After this stipulated date, no application Form will be received. It will be entirely the responsibility of the concerned institution if their forwardations are not accepted due to late receipt at this end.

Scholarship forms should be forwarded by the Principal/Head of Institution along with detailed list of applicant students, class –wise, Roll No. Enrolment/Regd.No. & date of Council / University, Bank Account Nos. with IFSC and MICR Code Nos. of each student in hard copy as well as soft copy in Microsoft Excel format in CD to the undersigned within the stipulated date. This office will not be in any way held responsible for furnishing of error/wrong Bank account numbers and Codes by the application/institutions.

**(C) NB (note well):**


(i) All the Institutions are required to submit an attested copy of affiliation order/letter & recognition letter of the institution (if not submitted earlier) as proof that the institution is affiliated to a Government recognized University/Council/Board and that the institutions is a Government recognized Institution.

(ii) Each applicant should furnish his/her Bank Account details neat & clearly in the Annexure-I and II (formats prescribed by the Govt.) which may be downloaded from Govt. website mentioned above. A Photostat copy of the first page portion of the Bank Passbook wherein account number, IFSC code etc. are visible should also be attached in the application Form.

(iii) A photocopy of **AADHAR CARD** is mandatory for every applicant.

(iv) All the applicants are advised to make sure that all the required documents mention in the application form are properly and securely attached. **A SCHOLARSHIP FORM ONCE REJECTED WILL NOT BE CONSIDERED AGAIN HENCEFORTH.**
